



INDEMNIFICATION AND FULL RELEASE OF ALL LIABILITY 2017 NIELLO CONCOURS AT SERRANO

The undersigned, desiring to participate in and to enter a vehicle in the 2017 Niello Concours at Serrano (NCS), does hereby tender this Entry Application. In the event the Application is accepted, then the undersigned agrees as follows:

- (1) The undersigned warrants and represents that they have read and understand the Rules and Regulations stated below and agree to abide and be bound thereby.
- (2) The vehicle is entered into the NCS at the owner's and exhibitor's own risk. The undersigned hereby releases Premier Concours Promotions, The Niello Company and Parker Development Company, Serrano Associates LLC., and the sanctioning organization, Sports Car Club of America, from any and all liability for any and all damages to the vehicle during the Concours.
- (3) The undersigned does hereby agree to indemnify, defend, and hold Premier Concours Promotions, Inc. and its volunteers, directors, officers, invitees, employees, agents and contractors harmless from and against all claims, demands, liabilities, damages, injuries, losses, fines or costs that arise out of my vehicle's entry in the NCS.
- (4) The undersigned does hereby agree to indemnify, defend, and hold Premier Concours Promotions, Inc. and its volunteers, directors, officers, invitees, employees, agents and contractors harmless from and against any and all liabilities, damages, causes of action, and expenses including attorney fees resulting from or relating to the undersigned's participation and anyone who accompanies undersigned in the NCS.
- (5) The undersigned agrees to restrict personal items around vehicle while on display. In order to ensure all participants and visitors have a memorable experience we must insist that all personal items including cleaning supplies, food items, etc. be kept out of sight during event. If needed a Concours approved box will be supplied.

RULES AND REGULATIONS 2017 NIELLO CONCOURS AT SERRANO

Entry requests must be approved by the Entries Committee, which reserves the right to reject any vehicle that does not meet the classifications or standards of the NCS. Applications complete with color photos and a check must be received by August 30, 2017. Entries received after this date may be accepted in accordance with space available and at the discretion of the committee. The committee reserves the right to limit class sizes and change or combine classes. A confirmation of acceptance letter will be emailed by September 6, 2017. All vehicles must be driven on to the field, trailers are not allowed on the field. Please remember no pets, no tents, pop-ups and no "For Sale" or commercial signage will be allowed. The event will be held rain or shine. Exhibitors must be with their vehicle during judging. Per SCCA ruling, specific cars will be in Concours as display only and will not be eligible for SCCA judging and awards but will be eligible for special awards or Best of Class Award. All 2016 Class Winners will not be eligible for SCCA judging but may be chosen for a Specialty Award.
ALL VEHICLES MUST CARRY A FIRE EXTINGUISHER.
